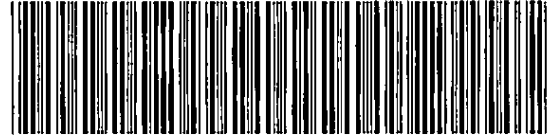

**CERTIFICATE OF DOMESTICATION
OF

The undersigned hereby files this Certificate of Domestication pursuant to Section 617.1803, Fla. Stat. (2024) with respect to Forward Free Foundation, Inc. (the "Corporation") under the laws of the State of Florida as follows:

**ARTICLE I
Original Incorporation Date and Jurisdiction**

The Corporation was first incorporated on April 24, 2018 in the State of Minnesota.


**ARTICLE II
Names**

The name of the Corporation immediately before the filing of this Certificate of Domestication was Forward Free Foundation. The name of the Corporation, as set forth in its Florida articles of incorporation is Forward Free Foundation, Inc.

**ARTICLE III

**ARTICLES OF INCORPORATION
OF
FORWARD FREE FOUNDATION, INC.**

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I
Name, Principal Place of Business, and Mailing Address

The name of the Corporation is: Forward Free Foundation, Inc. The principal place of business address is: 17206 Fountainside Loop #6112, Lutz, FL 33558. The mailing address is P.O. Box 1262, Odessa, FL 33556.

ARTICLE II
Purpose

The Corporation is organized and shall be operated exclusively for charitable, religious, and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), specifically limited to supporting Forward Free, Inc., an organization that is a tax exempt public charity pursuant to Code Sections 501(c)(3) and 170(b)(1)(A)(vi), which provides practical help to law enforcement officers, emergency service personnel, and disabled veterans while seeking opportunities to share the gospel.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

ARTICLE III
Members

The Corporation's only member shall be Forward Free, Inc.

ARTICLE IV
Registered Office and Agent

The street address of the registered office of the Corporation is 17206 Fountainside Loop #6112, Lutz, FL 33558, and the name of its registered agent at such address is Jonathan Trexel.

ARTICLE V

Directors

The Corporation shall have five (5) directors. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the Corporation, provided that the Corporation shall always have at least three directors. The name and address of each director of the Corporation who shall serve until his or her successor is duly elected and qualified are:

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors of the Corporation.

ARTICLE VIII

Amendment

These articles of incorporation may be amended in the manner provided by law.

ARTICLE IX

Dissolution

Upon a dissolution of the Corporation, the residual assets of the Corporation will be turned over to Forward Free, Inc., so long as it continues to be exempt as an organization described in Code Sections 501(c)(3) and 170(c)(2) and, if not, to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Code, or to the federal, state, or local government for exclusive public purpose.


ARTICLE X

Limitations

Section 1. Legislative and Political Activity. No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements in connection with) any political campaign on behalf of or in opposition to any candidate for public office.

Section 2. Property. The property, assets, profits, and net income of the Corporation are dedicated irrevocably to the purposes set forth herein. No part of the Corporation's profits or net earnings shall inure to the benefit of its directors, officers, members, or to the benefit of any private individual.
