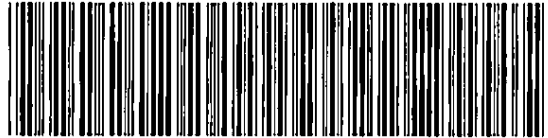

**ARTICLES OF INCORPORATION**  
**OF**

In Compliance with Chapter 617.F.S (Not for Profit)

**ARTICLE I - NAME**

This Corporation shall be known as Avanti Sinfonia Corporation a Florida not-for-profit corporation. (the "Corporation")

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business of the corporation is 7257 Firethorne Dr. Sarasota, FL. 34240, and the mailing address of the corporation is PO Box 5005, Sarasota, FL 34277.

**ARTICLE III - PURPOSE**

Said Corporation is organized for charitable, religious, educational, and scientific purposes, the making of distributions that qualify as exempt organizations under section 501c3 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of the Corporation is to:

- Provide the opportunity for professional, semi-professional, and accomplished musicians to present quality concerts of classical and new music at a moderate price to the Sarasota/Manatee communities and beyond.
- To showcase emerging soloists and composers, giving them the chance to present their work to the public.
- To educate the public about different genres of music through pre-concert talks and workshops including opportunities for your musicians to engage with performers in

#### ARTICLE IV - BOARD OF DIRECTORS

The management of the affairs of the corporation shall be vested in a board of directors, as defined be the corporation's by-laws. No director shall have any right, title, or interest in or to any property of the corporation.

#### ARTICLE VI - DURATION

The duration of the corporate existence shall be perpetual until dissolution as authorized by law.

The corporation is organized on a nonstick basis and shall not have the power to issue shares of stock in the corporation or interests in or other rights in any of its property, whether real of personal.

#### ARTICLE XI - EXEMPTION REQUIREMENTS

No part of the earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or the private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding sectional of any future federal tax code, or (b) by a corporation,

contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, the the corresponding section on any future tax code.

#### ARTICLE XII - DISSOLUTION OF CORPORATION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.


