Article III: The Corporation is organized exclusively for charitable, religious, educational, recreational, art, cultural, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. 1. Providing day care services, including daily living activities, recreational activities, and social services for individuals with developmental disabilities and elders in long-term care condition.
2. Offering vocational training, skill development programs, and therapeutic services aimed at improving participants' physical, cognitive, and emotional well-being.
3. Collaborating with other agencies, nonprofits, and governmental bodies to promote inclusion and improve services for adults with special needs or elders in Long-Term Care (LTC) condition.
