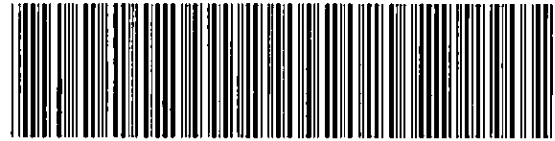



(Not for Profit)
OF
ABRAHAM SERBAZAN FOUNDATION, INC.**

Article I – Name

The name of the Corporation shall be Abraham Serbazan Foundation, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this corporation is organized is to preserve and promote Armenian classical literature, and seek to advance Armenian culture in general. In furtherance of such purposes, the corporation will endeavor to translate and promote the Armenian Church's classical works into modern languages, and distribute the same for educational objectives; the corporation will translate foreign classics into the Armenian language and publish and disseminate such works in order further cross-cultural awareness; the corporation will support educational programs which focus on training language experts in the art of translation; and the corporation will seek to promote the religious, social and cultural integrity of less fortunate populations in regions of Armenia.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.


