Articles of Incorporation of

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(19) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(19) of the Internal Revenue Code. The Corporation is organized and shall be operated on a not-for-profit basis and exclusively as a Veterans' Organization, within the meaning of Section 501(c)(19) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law).
