ARTICLES OF INCORPORATION OF Let The Blessing Flow Foundation, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME 6

The name of the corporation shall be: Let The Blessing Flow Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
