This corporation is founded exclusively for religious and charitable purposes within the meaning of the Internal Revenue Code section 501(c)(3), namely to establish or maintain one or more Churches for worship and fellowship, and there to provide worship services, spiritual guidance, community building, religious education, fellowship meals, spiritual events, lifecycle events, celebrations and other activities. This corporation is will carry out all its activities according to the Christian scriptures as understood by the elders of the church under the guidance of the church's Pastor. The church will promote the awareness of the Word of God. It will serve as a sign of the grace of God and that through His Son Jesus Christ, He offers to all people, at all times and in all places, eternal salvation, signs of which are that people are transformed by the Holy Spirit, that Divine Love is manifest, and that those inspired are called to proclaim God's love everywhere. The church will be a welcoming spiritual environment for those seeking the Divine presence in their lives. It will strive to live and preach the "Good News", by reaching out, encouraging and caring for those people who are objects of God's love. It will prepare people for redemption and teach the importance of serving God, serving the community and proclaiming God's Kingdom. It will carry out Works of Charity in the community, supporting the needy, uplifting the actions that are seen by the pastor or the directors as being in furtherance of the corporation's goals or conducive to the betterment of humanitude.

required for the operation of this corporation. The directors will adopt such decisions through in person meetings, telephonic conference calls, meetings via electronic media, written and signed consent, as well as by virtual signatures, all of which will be seen as equivalent to a vote cast at a meeting. Replies sent from emails belonging to directors or messages via any form of electronic communication belonging to directors, shall be seen as written signed consent to the proposal contained in the communication that is being replied to, and the equivalent of a vote cast at a meeting of the directors. The President will have the authority to open accounts on behalf of this corporation, at any bank, branch or financial institution that he may see fit. Alternatively, the president may instruct the directors to open bank accounts and serve as signatories on those accounts, individually, in pairs or in groups, in keeping with the instructions that were given to them.

Upon the dissolution of this corporation, all its remaining assets – after clearing all debts and liabilities— shall be distributed by the directors to one or more organizations with similar exempt purposes recognized under section 501(c)(3) of the IRS Code.
