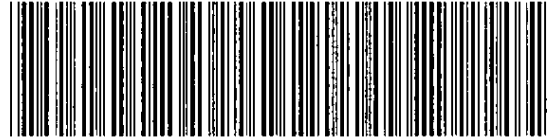

OF A FLORIDA NOT FOR PROFIT CORPORATION*

**KINGDOM GENIUS ENTERPRISES, INCORPORATED
ARTICLES OF INCORPORATION**

The undersigned, in compliance with Chapter 617, F.S., (Not for Profit), states as follows:

Article I - Name

The name of the corporation shall be Kingdom Genius Enterprises, Incorporated.

Article II – Principal Office

The principal street and mailing address is 922 Cherry Point Way, Jacksonville, Florida 32218.

Article III - Purpose

Kingdom Genius Enterprises, Incorporated (the "Organization") is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose for which the corporation is organized is to empower people to understand their true identity, unlock their full potential and unleash their best self. Also, to empower people to discover their spiritual intelligence and how to align with God and His Word.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the

corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV – Manner of Election

The directors shall be appointed as stated by the bylaws of the Organization.

Article V – Initial Directors

The initial directors are as follow:

Article VI – Registered Agent

Article VII - Incorporator

Article VIII - Dissolution

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
