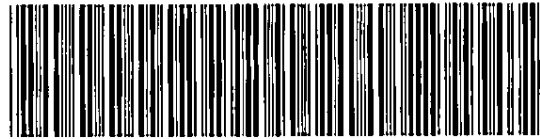

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
CORNERSTONE CLASSICAL FOUNDATION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, Cornerstone Classical Foundation, Inc., a Florida not for profit corporation (the "Corporation"), adopts the following amendments to its Articles of Incorporation:

1. Article VI is amended in its entirety to read as follows:

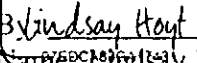
**"ARTICLE VI  
Directors**

The Corporation shall have three (3) directors. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the Corporation, provided that the Corporation shall always have at least three directors.
