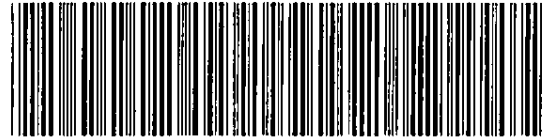

ARTICLES OF INCORPORATION
OF
ASIAN AMERICAN STORE OWNERS ASSOCIATION OF FL, INC.

The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I
Name

The name of this corporation shall be **ASIAN AMERICAN STORE OWNERS ASSOCIATION OF FL, INC.** (the "Corporation").

ARTICLE II
Term of Existence and Fiscal Year

The duration of the Corporation is perpetual.

ARTICLE III
Nature of Business

The Corporation is formed for all purposes permitted by law, with a primary focus on supporting, educating, and advancing the interests of retail store owners. Our mission includes promoting a thriving retail marketplace, protecting the mutual interests of our members in their relationships with each other and the public, and upholding the livelihood of our members. Additionally, we advocate for industry policies and regulations that align with and benefit our members' needs.

ARTICLE IV
Powers

This Corporation shall have all powers conferred by the laws of the State of Florida on Not for Profit corporations.

ARTICLE V
Capital Stock

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, its members, Board of Directors, officers, or other private persons, except that the Corporation is authorized and empowered to pay reasonable compensation for services rendered. The Corporation shall not carry on any activities not permitted to be carried on by a corporation tax-exempt under Internal Revenue Code Section 501(c)(6). Upon dissolution, the Corporation's assets remaining after payment of debts and liabilities shall be distributed exclusively for purposes within the intent of I.R.C. § 501(c)(3) or (6).

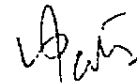
