

Pursuant to Section 617.0124, Florida Statutes, the incorporator of the above-referenced Florida corporation not-for-profit. Coral of Life Foundation, Inc. (the "Corporation"), files these Articles of Correction within fifteen (15) days of the filing date of the document being corrected, being the Corporation's Articles of Incorporation, as follows. These Articles of Correction correct the Corporation's Articles of Incorporation, filed with the Florida Department of State on November 19, 2024 as Document Number N24000013503, as follows.
