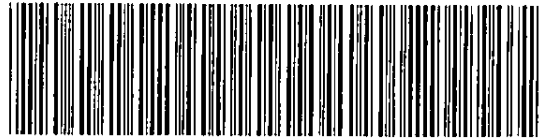

**"8. Directors**


