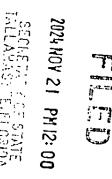

The undersigned, a majority of whom are citizens of the United States, desiring to form an official Charitable Corporation under the Non-Profit Corporation Law of the State of Florida do hereby certify:

| Name

The name of the corporation shall be Lisa Brady Inc.

Il Principal Office

The principal office of the Corporation is located in the City of Saint Petersburg, Pinellas County, State of Florida, United States of America. The physical street address is: 1101 54th Ave South, Saint Petersburg, Florida 33705

The purpose of Lisa Brady Inc is exclusively for charitable purposes in effort to 11. To align, advocate and serve members of the community to align, advocate and serve members of the community to protect against abuse, 2. t raise funds for education and services for sexual assault survivors and 3. to improve community moral with the local authorities to encourage calls for help.

Lisa Brady Inc qualifies for tax exempt status requirements under section 501(c)(3) oB the Internal Revenue Service Code F01 - Alliances and Advocacy. Lisa Brady Inc fully intends to comply with filing requirements to the Internal Revenue Service, including filing Form SS-4 / Applying for a Employer Identification Number (EIN) and Form 1023-EZ / Streamlined Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code.

Lisa Brady Inc also intends to fully comply with Florida State requirements by 1. registering with the Department of Agriculture and Consumer Services in compliance with the Chapter 496, F.S.
