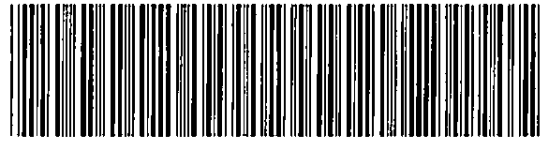

Articles of Incorporation of Lisa Brady Inc.

The undersigned, a majority of whom are citizens of the United States, desiring to form an official Charitable Corporation under the Non-Profit Corporation Law of the State of Florida do hereby certify:

I Name

The name of the corporation shall be Lisa Brady Inc.

II Principal Office

The principal office of the Corporation is located in the City of Saint Petersburg, Pinellas County, State of Florida, United States of America. The physical street address is: 1101 54th Ave South, Saint Petersburg, Florida 33705

III Purpose

The purpose of Lisa Brady Inc is exclusively for charitable purposes in effort to 1. align, advocate and serve members of the community to protect against abuse, 2. to raise funds for education and services for sexual assault survivors and 3. to improve community moral with the local authorities to encourage calls for help.

Lisa Brady Inc qualifies for tax exempt status requirements under section 501(c)(3) of the Internal Revenue Service Code **F01 - Alliances and Advocacy**. Lisa Brady Inc fully intends to comply with filing requirements to the Internal Revenue Service, including filing Form SS-4 / Applying for a Employer Identification Number (EIN) and Form 1023-EZ / Streamlined Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code.

Lisa Brady Inc also intends to fully comply with Florida State requirements by 1. registering with the Department of Agriculture and Consumer Services in compliance with the Chapter 496, F.S. Solicitation of Contributions Act, 2. filing State required annual reports and 3. Adhering to State laws regarding the filing of required Department of Revenue tax returns, as applicable.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall

not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporation shall not engage in any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code nor shall it engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

IV Manner of Election

The manner in which the directors are elected and appointed is by a meeting of all participants and an agreement of all participants. In the case of the removal or replacement of, the manner remains the same with the exception of majority rule, two votes to remove a member supersedes oneself-vote to remain a member.
