ARTICLES OF INCORPORATION
(In Compliance with Chapter 617, F.S., (Not for Profit))

Article I - Name

The name of the organization shall be **Jeanette Lindsey Ministries, Inc.**

Article II - Principal Place of Business

The principal place of business and mailing address of the corporation shall be

Article III - Purpose

The purpose and mission for which the organization is organized, is ministering and evangelizing the gospel through teaching and preaching the Word of God. To conduct conferences, workshops and provide training that will empower leaders, churches, and other organizations. Said organization is organized exclusively for charitable and religious purposes.




