## ATTACHMENT TO ARTICLES OF INCORPORATION OF THE JORNDT FAMILY CHARITABLE FOUNDATION, INC.

#### ARTICLE III: PURPOSES

THE JORNDT FAMILY CHARITABLE FOUNDATION, INC. (the "Corporation") is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Specific focus will be the advancement of education, religion, conservation, the arts, health and welfare by donation to other qualifying organizations and other 501(c)(3) charities.

#### ARTICLE IX: OTHER PROVISIONS

<u>INUREMENT OF INCOME</u>: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

LEGISLATIVE OR POLITICAL ACTIVITIES: No substantial part of the activities of the Corporation shall be the carrying of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

OPERATIONAL LIMITATIONS: Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions, to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

DISSOLUTION CLAUSE: Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, dispose of all the assets of the Corporation exclusively for the purposes of the Corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for the such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
