ARTICLES OF INCORPORATION

OF

A1 Horses Helping Humans Cope, Inc

We, the undersigned, do hereby associate ourselves together for the purpose of forming a Corporation Not For Profit, under and by virtue of Chapter 617, Florida Statutes, and do hereby adopt as and for the corporation charter of said corporation, the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation shall be:

ARTICLE II: PRINCIPLE OFFICE AND MAILING ADDRESS

ARTICLE III: PURPOSE

The purposes for which this Not-For-Profit Corporation is organized are:

To provide equine-assisted services, including therapy and education, to trauma victims and children with special needs, promoting physical, emotional, and mental wellbeing. Within the meaning of Section 501(c)(3) of the Internal Revenue Code. It is not organized for the private gain of any person and such purposes shall include the following:

- (a) Education, and therapy to special needs children, and trauma victims.
While also promoting good physical, emotional, and mental health.
- (b) To conduct any legal activity permitted to be conducted by nonprofit Corporations under the laws of the State of Florida and Section 501(c)(3) of the United States Internal Revenue Code. More specifically, but without reservation or restriction, this Corporation shall be organized and operated exclusively for charitable, scientific, literary and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended, or any superseding section.
- (c) To do such other things as may be necessary and proper to carry out and accomplish the above objects and purposes, and to exercise all rights and powers conferred by the State of Florida upon non-profit corporations.

(d) All property shall be irrevocably dedicated to charitable purposes and shall be held in the corporate name of A1 Horses Helping Humans Cope, Inc. A1 Horses Helping Humans Cope, Inc is a nonprofit corporation organized and operated exclusively for charitable, scientific, literary and educational purposes, which qualifies for exemption from Federal Income Tax under provision of Section 501(c)(3) of the Internal Revenue Code. The purchase, sale lease, mortgage or alienation of said real property shall be transacted according to the by-laws of the corporation.

ARTICLE IV: DISTRIBUTION OF CORPORATE FUNDS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(e)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V: MANNER OF ELECTION OF DIRECTORS

The business and affairs of this corporation shall be conducted by a Board of Directors who shall number not less than three. Said directors shall have the authority and power to increase or decrease the number of serving directors within the limits provided in the Bylaws of the Corporation. The Board of Directors shall be elected as provided for in the Bylaws and serve until their successors are elected and qualified.

ARTICLE VI: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302 of the Florida Statutes.

ARTICLE VII: TERM

The term for which this corporation shall exist shall be perpetual. And to be made effective;




