


# ATTACHMENT TO ARTICLES OF INCORPORATION PURPOSE AND ADDITIONAL PROVISIONS

This corporation is founded exclusively for charitable purposes within the meaning of the IRS Code Sec 501(c)(3); namely: lessening eliminating prejudice, discrimination, antisemitism and hatred between people, be they in Florida, elsewhere in the US, in Israel or around the world. It will strive to bring about better societies based on the principles of Judaism and of the Hebrew prophets. This corporation will seek to defend human and civil rights as secured by law, to combat community deterioration and to struggle against misunderstanding, violence and cruelty. It will advocate for the evolution and transformation of society through non-revolutionary compassionate means that will increase mutual understanding and harmony. It will explicate the meaning of the Israelite Nation as a manifestation of Gods kingdom an earth and teach practical methods for the spiritual rectification of society on behalf of all human beings. Through inspirational events, teaching sessions, courses, retreats, meetings, visitations and other activities, this corporation will spread its message of honesty, humility and compassion for all. It will carry out its activities in keeping with the principles of Judaism under the directions of its Rabbi, who is the President of this corporation. Likewise, it will carry out any additional activities that are seen by the directors to be in furtherance of the above stated purposes and objectives.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, for work done, resources purchased or properties acquired that are seen by the directors to be in furtherance of its exempt purposes. This corporation will be empowered to rent or buy personal or real property, in order to carry out its activities and to provide a suitable location for its activities, as well as a parsonage for the Rabbi or for any religious functionaries it may employ.

Upon the filing of these articles of incorporation with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers, to file forms with government agencies and undertake any other action required for the operation of this corporation. Likewise, replies sent from emails, or other forms of online communication belonging to directors shall be seen as written signed consent to the proposal being responded to, and as the equivalent of a vote cast at a meeting of the directors.

In the event of this corporation's dissolution, the directors will —after clearing all debts and liabilities— distribute any remaining funds or assets to other charitable organizations recognized by the IRS under section 501(c)(3) that have similar purposes.
