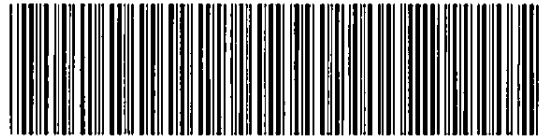

### **Articles of Incorporation**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

#### **Article I: Name**

The name of the corporation is Verified Crowdfunding, Inc.

#### **Article II: Principal Location**

The principal office address of the corporation is P.O. Box 41, Odessa, FL 33556.

#### **Article III: Purpose**

The corporation is organized exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
