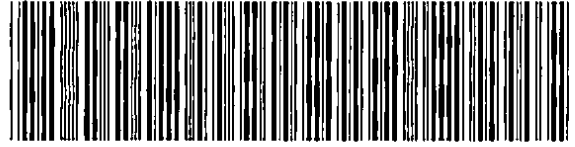

# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I NAME:

The name of the corporation shall be: RESTORE OUR SONS AND DAUGHTERS INC.

## ARTICLE II PRINCIPAL OFFICE:

## ARTICLE III PURPOSE:

The purpose for which the corporation is organized is: Restore Our Sons and Daughters Inc. is a non-profit Incorporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the Corresponding section of any future federal tax code.

### **3.1 Purpose**

1. The specific purpose of this Incorporation is to:

a. Provide an effective forum for interaction, problem solving and discussion of clinical research issues among research professionals.

b. Provide a working relationship with other Nonprofits who promote criminal justice reform, one of the most underdeveloped dimensions of deterrence and a significant part of why it fails so profoundly in this country is that people are not guaranteed the benefits of full healthy participation in our society when they abide by the law. We have to encourage our children that the American Dream works with hard work.

c. Provide education, including offering continuing vocational training for at risk kids to prevent exposure to criminal justice system.

d. Provide Social Justice: by creating and promoting a comprehensive system of Parole which saves tax payers \$1.6 billion dollars over ten (10) years by a purposed amendment to our State Constitution, which will guarantee each offender a second chance at (1) acknowledging responsibility for our actions. (2) acknowledging the impact of our actions on others; (3) expressing genuine remorse; (4) taking actions to repair the harm to the degree possible, and guided

when feasible by people harmed, or “doing sorry”, and (5) no longer committing similar harm (6) promote Restorative Justice.

e. Provide Reentry Housing: To work in conjunction with other nonprofits to assure returning citizens have an affordable place to live. Many prisoners return to prison due directly to not being able to find affordable housing. We aim to work with other nonprofits to provide that housing in every Florida city and county throughout this State.

f. Faith: To work with State and local officials to utilize community churches to feed, house, and provide counseling to returning citizens.

### **3.2 Public Benefit**

Restore Our Sons and Daughters Inc. is designed as a public benefit corporation.

Advisory board members will be appointed by a majority of board members to serve as members who have a vested interest in the growth and development of the company.
