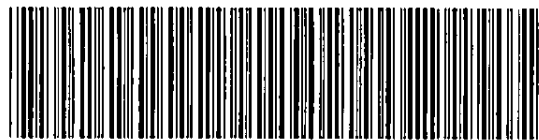

NOT-FOR-PROFIT ARTICLES OF INCORPORATION

Article I: Name

Effective Date: 01-01-2025

The name of this corporation shall be: **Unity Church of Christ Health Services Inc.**

Article II: Principal Office

The principal office of Unity Church of Christ Health Services Inc. shall be located at:

100 N. State Rd 7, Margate FL 33063, in Broward County, Florida, with services provided in both Broward County, Florida, and Haiti. The Board of Directors may change this location as necessary.

Article III: Purpose

This corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The primary purpose of Unity Church of Christ Health Services Inc. is to provide accessible healthcare and health education services to immigrant and underserved communities in Broward County, Florida, and Haiti. These services aim to improve physical, mental, and spiritual well-being, in alignment with Christian faith and principles.

Vision Statement:

Unity Church of Christ Health Services Inc. envisions a world where every individual, regardless of background or origin, experiences the fullness of health, healing, and hope. Rooted in faith, we aspire to empower immigrant communities and underserved surrounding families in Broward County and Haiti with compassionate care, strengthening their bodies, minds, and spirits for a brighter future.

Mission Statement:

Guided by Christ's love, Unity Church of Christ Health Services Inc. is dedicated to improving the health and well-being of underserved communities in Broward County and Haiti. Through accessible, holistic healthcare, health education & awareness, behavioral health and community support, we are committed to lifting up immigrant families and individuals, fostering resilience, and building healthier lives. Our mission is to serve as a beacon of faith and healing, bringing communities together to create lasting, impactful change for generations.

Article IV: Specific Objectives and Activities

- **Healthcare Services** - Provide accessible and affordable health services, behavioral health, preventive care and treatment to underserved individuals, focusing on immigrants and the underserved communities and families in Broward County, Florida, and Haiti.
- **Health Education** - Conduct educational workshops, training, and community outreach programs promoting health awareness, disease prevention, and wellness.
- **Community Support** - Offer resources and support to families, encouraging health and resilience through holistic care that respects the dignity and cultural needs of each individual.
- **Faith-Based Guidance** - Integrate Christian values and spiritual support as part of holistic health services to foster a compassionate and inclusive environment.

Article V: Limitations and Restrictions

Nonprofit Status - Unity Church of Christ Health Services Inc. shall operate as a nonprofit corporation. No part of its net earnings shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its stated purpose.

Legislative and Political Activities - No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Dissolution Clause - Upon the dissolution of Unity Church of Christ Health Services Inc., any remaining assets shall be distributed exclusively for exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of the corporation is then located, exclusively for such purposes.

Article VI: Membership

Unity Church of Christ Health Services Inc. shall have no members as defined in the Florida Non-profit Corporation Act. The corporation shall be governed by a Board of Directors, who shall have full authority to conduct the affairs of the corporation.

Article VII: Board of Directors

- **Governing Body** - The corporation shall be governed by a Board of Directors, who shall have full authority to conduct the affairs of the corporation.
- **Number of Directors** - The Board shall consist of no fewer than three (3) directors. The exact number shall be fixed by the corporation's bylaws.
- **Election and Terms** - Directors shall be elected as specified in the bylaws of the corporation.

Article X: Exempt Status Requirements

This corporation shall comply with the requirements of Section 501(c)(3) of the Internal Revenue Code, including any applicable regulations or statutory provisions. In particular:

This corporation shall not engage in any activity not permitted by a corporation exempt from federal income tax under Section 501(c)(3) or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

This corporation shall not lend any part of its income or assets to, nor pay any compensation in excess of reasonable value for services rendered to, any director, officer, or other private individual.
