**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

The Articles of Incorporation of **PLATOON WAVES, INC.**, a Florida Not for Profit Corporation (the "**Corporation**"), were filed on December 19, 2024, and assigned Florida document number N24000014718.

Pursuant to Section 617.1006, Florida Statutes, the Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE I
Amendment**

This Amendment changes the name of the Corporation to **PLATOON WAVE, INC.** and, therefore, the old Article I of the Corporation's Articles of Incorporation is hereby deleted and a new Article I is added and shall read as follows:

**"ARTICLE I
NAME AND ADDRESS**


The name of this corporation shall be: **PLATOON WAVE, INC.** (hereinafter called the "**Corporation**").
