

Articles of incorporation

of

Bright Minds Academy of Clearwater, Inc.

We, the undersigned, hereby associate ourselves together for the purpose of being a corporation not-for-profit under chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not-for-profit.

Article I. Name

The name of this corporation shall be Bright Minds Academy of Clearwater, Inc.

Article II. Principal Office

The principal place of business of the corporation is:

The mailing address of the corporation is:

Article III. Purpose

Bright Minds Academy of Clearwater, Inc. is organized exclusively for educational and charitable purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Bright minds Academy of Clearwater, Inc. may raise funds, request and receive grants, gifts, contributions, and bequeaths of money, real and personal property; or acquire, receive, hold, invest and administer, in its own name, securities, funds, objects of value, or other property, real and personal, and make expenditures and distributions for the benefit of the Bright Minds Academy of Clearwater school, in a manner as the board of directors may determine to be appropriate to further its educational and charitable purpose, and shall have all the powers conferred by or permissible under the Florida not-for-profit Corporations Act.

Article IV- Prohibited Activities

No part of the net earnings of Bright Minds Academy of Clearwater, inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set in its Articles of Incorporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V. Board of Directors

Bright Minds Academy of Clearwater, Inc shall have a board of directors that will govern all activities of the Bright Minds Academy of Clearwater, Inc, specified in the Bylaws. The Bylaws shall also provide for their duties, functions and manner of election. The board of directors shall manage the affairs of the corporation. The names and the street addresses of the members of the first board of directors and officers, all of whom shall hold office until their successors are duly elected and qualified are as follows:

Bright minds Academy of Clearwater Inc. has an effective start date of January 1st, 2025 Bright minds Academy of Clearwater Inc. shall exist perpetually unless dissolved in accordance with the Bylaws.

Article VIII- Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX- Bylaws

The bylaws of the corporation shall be adopted by the board of directors and shall be altered, amended or resend it in the manner provided by the Bylaws.
