Article VI - Consolidation of Equity Tennis and Equity Sports into Equity Social: These changes eliminate the Tennis and Sports member classes. Members in the Social class will have the option to purchase a "buy-up" to Tennis or Sports.

Article XII - Board of Governors Composition and Member voting rights. Reduces the size of the Board of Governors from fifteen Board members to eleven. The eleven seats are allocated to three Social (at least one of which must be a holder of a Tennis or Sport Buy-Up and eight Golf. One equity member for each membership can vote for all open seats on the Board of Governors regardless of member class.
