Pursuant to the provisions of Section 617.1006 of the Florida Statutes, **WATERMAN COMMUNITIES, INC.**, a Florida Not-For-Profit Corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **WATERMAN COMMUNITIES, INC.**
2. The original Articles of Incorporation for the Corporation were filed on December 28, 1987, with an effective date of December 22, 1987, and assigned Charter No. N24182, and were thereafter further amended.

The amendment was adopted by the Board of Directors of the Corporation on the 26th day of July, 2010, and the number of votes cast for the amendment was sufficient for approval. There are no members entitled to vote on the amendment.

Article XV - Acquisition of Assets by Adventist Health System Sunbelt Healthcare Corporation is hereby deleted in its entirety
