As the newly elected Secretary of this organization I am trying to get the corporation all straightened

We had a new resident as secretary last year and she neglected to leave the key for the Pioneer's mailbox with someone else while she was gone on a trip to Michigan to settle her son's affairs. She had the only key to the Pioneers mailbox.

On the way up north she was involved in an automobile accident. She was able she returned home in late June. She issued her resignation, put her mobile home on the market and sold out. She turned a box of papers and the mailbox key to our President. The Treasurer who is a snowbird was in New York the president gave the mail key to the acting treasurer. The letter referred to date Jan. 28, 2003, was never seen by the acting secretary so she says. The secretary must have thrown it away, thinking it was regarding dues she knew were paid.

In July they did get a letter telling them the dues weren't paid, so the acting treasurer sent another check for \$61.25 to pay the dues and they never heard anything else.
