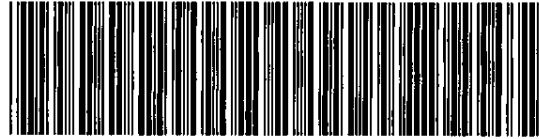

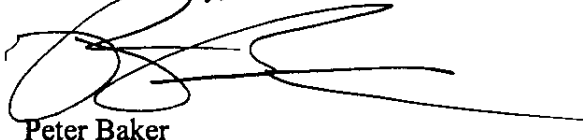

SECOND ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION AND CONSTITUTION
OF
EXCHANGE CLUB OF TAMPA, INC.

Under the provisions of F.S. 617.1006, and ARTICLE XIII, this Florida Not-For-Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation and Constitution:

FIRST: Amendments adopted:

ARTICLE VII is amended by deleting current Section 1 and replacing it with the following new text:

Section 1. The officers of this Club shall be a President, a Vice President, a Treasurer and a Secretary.

ARTICLE VII is amended by deleting the first sentence of current Section 5 and replacing it with the following new sentence:

Section 5. The terms of all officers shall be for a period of one (1) calendar year, from January 1 to December 31 of the year following the year of the annual election, or until their successors have been duly chosen and assume office.

The remainder of current Section 5 shall remain unchanged.


ARTICLE VII is amended by deleting current Section 6 and replacing it with the following text:

Section 6. The Vice President shall automatically succeed to the office of President; the Secretary shall automatically succeed to the office of Vice President; and the Treasurer shall automatically succeed to the office of Secretary. A new Treasurer shall be selected annually as provided in the Bylaws. The retiring President shall remain as a director only for a term of one (1) additional year unless re-elected as a new director at the next annual election meeting as provided in the Bylaws.

SECOND: The foregoing Amendments were adopted at a meeting of the Members held on Monday, January 22, 2007, pursuant to notice, and became effective immediately. The number of votes cast for the Amendments was sufficient for approval.
