## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BENT CREEK PROPERTY OWNERS' ASSOCIATION, INC. (A CORPORATION NOT FOR PROFIT)

Pursuant to §617.1006 of the Florida Statutes, the Articles of Incorporation of BENT CREEK PROPERTY OWNERS' ASSOCIATION, INC., ("BENT CREEK") is hereby amended pursuant to a vote of a majority of the Board of Directors and pursuant to Article X of the Articles of Incorporation for BENT CREEK, dated January 7, 1988, and recorded March 30, 1988 in Official Record Book 5618, Page 1400 of the Public Records of Palm Beach County, Florida as amended.

1. This Amendment hereby amends Article VI of the Articles of Incorporation of Bent Creek Property Owners' Association, Inc. as follows: (additions indicated by underline, deletions indicated by strikethrough)

## "VI. BOARD OF DIRECTORS

- 1. The affairs of the Association shall be managed by a Board of Directors consisting of five (5) Directors. All Directors shall be Lot Owners, or Resident immediate family member of Let Owners. Elections shall be by plurality vote. As many Directors shall be elected and appointed, as the case may be, as there are regular terms of office of Directors expiring at such time, and the term of the Director so elected or appointed at each annual election shall be for two (2) years expiring at the second (2<sup>nd</sup>) annual election following their election, and thereafter until their successors are duly elected and qualified, or until removed from office with or without cause by the affirmative vote of a majority of the Members which elected or appointed them."
- II. Except as amended and modified herein, all other terms and conditions of the Articles of Incorporation for Bent Creek shall remain in full force and effect according to their terms.
- III. This Amendment has been proposed and adopted on the 32 day of 200½, by the Board of Directors, in accordance with §607.0120 of the Florida Statutes.
