

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

THE CLUB VILLAS II AT PALM AIRE CONDOMINIUM ASSOCIATION, INC.

ARTICLE 1. NAME OF CORPORATION AND PRINCIPAL OFFICE

The name of this corporation is THE CLUB VILLAS II AT PALM AIRE CONDOMINIUM ASSOCIATION, INC. (herein "the Association"). The principal office of the Association is located at 2011 Bispham Road, Sarasota, Florida 34231. The Association Board of Directors (herein "the Board") may change the location of the principal office of the Association from time to time.

ARTICLE 2. PURPOSE

This Association is organized for the purpose of providing an entity under the Florida Condominium Act (Chapter 718, Florida Statutes) for the operation of a condominium located in Manatee County, Florida, and known as THE CLUB VILLAS II AT PALM AIRE CONDOMINIUM (herein "the Condominium"), created pursuant to the Declaration of Condominium (herein "the Declaration").

ARTICLE 3. DEFINITIONS

The terms used herein shall have the same definitions as stated in the Declaration of Condominium and the Condominium Act unless the context requires otherwise. If there is a dispute over the proper definition of a vague or ambiguous term which is not otherwise defined by the Declaration of Condominium or by the Condominium Act, the Board shall provide a reasonable definition of the term or may adopt any standard dictionary definition of the term.

ARTICLE 4. POWERS

The Association shall have all of the statutory powers and common law powers of a corporation not for profit and all of the powers and duties set forth in the Florida Not for Profit Corporation Act (Chapter 617, Florida Statutes), the Condominium Act, the Declaration, these

Articles of Incorporation, and Bylaws of the Association, all as amended from time to time, except as may be limited or otherwise provided by these Articles of Incorporation or by law. The powers of the Association shall be subject to and shall be exercised in accordance with the provisions of the Declaration and Bylaws.

ARTICLE 5. MEMBERS

The qualification of Members, the manner of their admission, and their voting rights shall be as regulated by the Bylaws.

ARTICLE 6. VOTING RIGHTS

The Owners of Units shall be entitled to cast one (1) vote for each Unit owned. The vote of a Unit is not divisible.

ARTICLE 7. TERM

The term for which this Association is to exist shall be perpetual, unless sooner dissolved pursuant to provisions of Chapter 617 of the Florida Statutes, as amended from time to time, or other pertinent law.

ARTICLE 8. BOARD OF DIRECTORS

The affairs and operation of the Association shall be managed by a governing board called the Board of Directors. The Bylaws shall provide for the number, election, removal, qualification and resignation of the Directors and for filling vacancies on the Board.

ARTICLE 9. OFFICERS

The officers of the Association shall be selected by the Board. They shall perform such duties as shall be provided by the Bylaws of the Association.

ARTICLE 10. BYLAWS

The Bylaws of the Association may be amended in the manner provided in the Bylaws.

ARTICLE 11. AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- A. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which the proposed amendment is considered.
- B. A resolution for the adoption of a proposed amendment may be proposed by vote of not less than a majority of the entire membership of the Board.
- C. Except as otherwise required by law, a proposed amendment to these Articles of Incorporation shall be adopted if it is approved by vote of not less than a majority of the Voting Interests of the Association present and voting in person or by proxy at a duly noticed and convened membership meeting.
- D. An amendment shall become effective upon filing with the Secretary of State and recording a copy in the Public Records of Manatee County, Florida.

ARTICLE 12. REGISTERED OFFICE AND REGISTERED AGENT

The registered office of the Association shall be located at 2011 Bispham Road, Sarasota, FL 34231, and the registered agent at such address shall be Prokop, P.A. The Board may change the registered agent and office from time to time as permitted by law.
