ARTICLES OF INCORPORATION OF VIVANT HOMEOWNERS ASSOCIATION, INC.

In compliance with the requirements of the laws of the State of Florida, the following are the Articles of Incorporation for Vivant Homeowners Association, Inc.

- 1. Name. The name of the corporation shall be Vivant Homeowners Association, Inc. (the "Association").
- 2. <u>Principal Office</u>. The principal office of the Association is 5505 Waterford District Drive, 5th Floor, Miami, Florida 33126.
- 3. Registered Office Registered Agent. The street address of the Registered Office of the Association is Association Law Group, P.L., 1100 Brickell Bay Drive, Suite 5200, Miami, Florida 33131. The name of the Registered Agent of the Association is:

ASSOCIATION LAW GROUP, P.L.

- 4. <u>Definitions</u>. A declaration entitled Declaration for Vivant (the "<u>Declaration</u>") has been (or will be) recorded in the Public Records of Miami-Dade County, Florida, and shall govern all of the operations of the community to be known as Vivant (the "<u>Community</u>"). All initially capitalized terms not defined herein shall have the meanings set forth in the Declaration.
- 5. <u>Purpose</u>. Association is formed to: (a) provide for ownership, operation, maintenance and preservation of the Common Areas, and improvements thereon; (b) perform the duties delegated to it in the Declaration; (c) administer the interests of Association and the Owners; (d) promote the health, safety and welfare of the Owners.
- 6. Not-for-Profit. Association is a not-for-profit Florida corporation and does not contemplate pecuniary gain to, or profit for, its members.
- 7. <u>Powers and Duties</u>. The powers of the Association shall include and be governed by the following:
- 7.1. To perform all the duties and obligations of Association set forth in the Declaration and By-Laws, as herein provided.
- 7.2. To enforce, by legal action or otherwise, the provisions of the Declaration and By-Laws and of all rules, regulations, covenants, restrictions and agreements governing or binding Association and Vivant.
- 7.3. To fix, levy, collect and enforce payment, by any lawful means, of all Assessments pursuant to the terms of the Declaration, these Articles and By-Laws.
- 7.4. To pay all Operating Costs, including, but not limited to, all licenses, taxes or governmental charges levied or imposed against the property of Association.
- 7.5. To acquire (by gift, purchase or otherwise), annex, own, hold, improve, build upon, operate, maintain, convey, grant rights and easements, sell, dedicate, lease, transfer or otherwise dispose of real or personal property (including the Common Areas) in connection with the functions of Association except as limited by the Declaration.
- 7.6. To borrow money, and to mortgage, pledge or hypothecate any or all of its real or personal property as security for money or debts incurred.
- 7.7. To dedicate, grant, license, lease, concession, create easements upon, sell or transfer all or any part of Vivant to any public agency, entity, authority, utility or other person or entity for such purposes and subject to such conditions as it determines and as provided in the Declaration. (1)
- 7.8. To participate in mergers and consolidations with other non-profit corporations organized for the same purposes.

- 7.9. To adopt, publish, promulgate or enforce rules, regulations, covenants, restrictions or agreements governing Association, Vivant, the Common Areas, Lots, Parcels and Homes as provided in the Declaration and to effectuate all of the purposes for which Association is organized.
- 7.10. To have and to exercise any and all powers, rights and privileges which a not-for-profit corporation organized under the laws of the State of Florida may now, or hereafter, have or exercise.
- 7.11. To employ personnel and retain independent contractors to contract for management of Association, Vivant, and the Common Areas as provided in the Declaration and to delegate in such contract all or any part of the powers and duties of Association.
- 7.12. To contract for services to be provided to, or for the benefit of, Association, Owners, the Common Areas, and Vivant as provided in the Declaration, such as, but not limited to, Telecommunications Services, maintenance, garbage pick-up, and utility services.
