

ARTICLES OF INCORPORATION

MOJO'S HOUSE, INC.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, educational, and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.
