#### ARTICLES OF INCORPORATION

# FOREST ACRES PROFESSIONAL PROPERTIES ASSOCIATION, INC. (a Corporation Not-for-Profit)

The undersigned do hereby associate themselves for the purpose of forming a corporation not for profit as allowed by Chapter 617 of the Florida Statutes. Pursuant to the provisions and laws of the State of Florida, we certify as follows:

# ARTICLE I-NAME AND PRINCIPAL PLACE OF BUSINESS OF THE CORPORATION

The name of this corporation, hereinafter called the "Association," shall be FOREST ACRES PROFESSIONAL PROPERTIES ASSOCIATION, INC. Its initial principal office and place of business shall be at 5831 Beverly Drive, Hudson FL. 34667. The Board of Directors of the Association may from time to time move the principal office of the Association to any other address in the State of Florida.

#### ARTICLE II- PURPOSE

The purpose for which the Association is organized is to provide for the preservation of the values, beneficial uses, environmental protections, and functional desirability of the property known as "Forest Acres Professional Properties," which is a commercial property, and in order to provide for the administration and maintenance of certain portions of said real property and for the enforcement of the covenants and restrictions contained in the Declaration of Covenants and Restrictions for Forest Acres Professional Properties.

#### **ARTICLE III - POWERS**

The powers of the Association shall include and be governed by the following provisions:

- 3.1 The Association shall have all of the common law and statutory powers of a corporation not for profit under Florida law not in conflict with the terms of these Articles of Incorporation.
- 3.2 The Association shall have all of the powers and duties set forth in Section 617.0302, Florida Statutes, the Declaration of Covenants and Restrictions for Forest Acres Professional Properties ("Declaration of Covenants") and these Articles of Incorporation. In the event of a conflict between these powers and Chapter 617, these Articles shall prevail.
- 3.3 The powers of the Association shall be subject to and shall be exercised in accordance with the provisions of the Declaration of Covenants and the Bylaws.

- 3.4 Notwithstanding anything herein to the contrary, the Association shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(7) of the Internal Revenue Code and its regulations as the same now exist or as they may be hereinafter amended from time to time.
- 3.5 These Articles of Incorporation shall not be construed to give the Association any powers not authorized by Section 617.0302, Florida Statutes.

#### ARTICLE IV - MEMBERSHIP

The members of the Association shall consist of all the owners of property in Fores Acres Professional Properties.

#### ARTICLE V - TERM OF EXISTENCE

The existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall have perpetual existence.

#### **ARTICLE VIII - BYLAWS**

The Bylaws of the Association are to be made or approved by the Board of Directors initially and thereafter may be amended, altered, modified or rescinded by the action or approval of the Board of Directors of the Association. The manner of altering, modifying, amending, or rescinding the Bylaws shall be provided for in the Bylaws.

#### ARTICLE IX - AMENDMENTS TO THESE ARTICLES

- 9.1 Amendments to these Articles of Incorporation shall be proposed to the membership of the Association in writing. A majority affirmative vote of the total number of votes in the Association shall be necessary to amend these Articles of Incorporation.
- 9.2 No amendment shall be made that is in conflict with the Declaration of Covenants.

#### ARTICLE X - MEMBER VOTING

- 10.1 Each property owner shall have one (1) vote. All votes may be exercised or cast in such manner as may be provided in the Bylaws of the Association.
- 10.2 Votes may be cast either in person or by proxy. All proxies must be in writing and filed with the Secretary before the convening for each meeting. Any proxy given shall be effective only for the specific meeting for which originally given and any lawfully adjourned meeting thereof.

#### **ARTICLE XI - ADDITIONAL PROVISIONS**

- 11.1 The Association shall not be operated for profit. No dividend shall be paid, and no part of the income of the Association shall be distributed to its members, directors, officers, or members.
- 11.2 Every member of the Board of Directors and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including attorney's fees reasonably incurred by or imposed upon him or her in connection with any proceeding or any settlement of any proceeding to which he or she may be a party, or in which he or she may become involved, by reason of his or her being, or having been, a member of the Board of Directors, or officer of the Association except in such cases wherein the director, or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his or her duties, whether or not he or she is a member of the Board of Directors or officer at the time such expenses are incurred.

#### **ARTICLE XII - SEVERABILITY**

Should any paragraph, sentence, phrase, or portion thereof, of any provision of these Articles or of the Bylaws or rules and regulations be held invalid, it shall not affect the validity of the remaining parts thereof or of the remaining instruments.

#### ARTICLE XIII - APPOINTMENT OF INITIAL AGENT FOR SERVICE OF PROCESS
