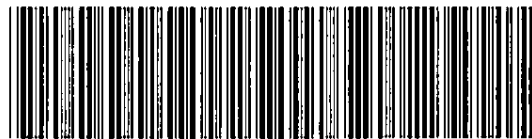

**ARTICLES OF INCORPORATION
OF

ARTICLE I

Corporate Name

The name of this corporation is **FLIGHT 19 MODEL CLUB, INC.**, and shall be a nonprofit corporation organized under the Florida Not for Profit Corporation Act.

ARTICLE II

Principal of Office

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

General and Specific Purpose

This is a nonprofit corporation, organized solely for the purpose of promoting education and fostering a spirit of competition within the scale modeling hobby.

A: Activities include organizing seminars on model building techniques, as well as delving into the rich historical backgrounds of the subjects depicted in models. By sharing expertise and passion our aim is to inspire the next generation of model builders and enthusiasts.

B: This club will actively promote competition as a means of honing skills and celebrating excellence in scale modeling. These events will serve as a platform for skill development and as a source of camaraderie and community building.

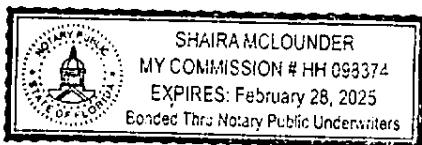
