ARTICLES OF INCORPORATION **OF**

We, the undersigned, do hereby associate ourselves together for the purpose of forming a Corporation Not For Profit, under and by virtue of Chapter 617, Florida Statutes, and do hereby adopt as and for the corporation charter of said corporation, the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation shall be:

ARTICLE II: PRINCIPLE OFFICE AND MAILING ADDRESS

ARTICLE III: PURPOSE

The purposes for which this Corporation is organized are:

To operate exclusively for religious, charitable, educational, and distinct ecclesiastical purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, and such purpose shall include the following:

To spread the message of the gospel by traveling in our gospel truck in the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable word of God.

ARTICLE IV: DISTRIBUTION OF CORPORATE FUNDS

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue

on (a) by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V: MANNER OF ELECTION OF DIRECTORS

The business and affairs of this corporation shall be conducted by a Board of Directors who shall number not less than 3. Said directors shall have the authority and power to increase or decrease the number of serving directors within the limits provided in the Bylaws of the Corporation. The Board of Directors shall be elected as provided for in the Bylaws and serve until their successors are elected and qualified.
