**ARTICLES OF INCORPORATION  
OF  
DIGITAL DATA TRUST, INC.**

*a Florida Not-For-Profit Corporation*

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a not-for-profit corporation under the Florida Not for Profit Corporation Act (the "Act").

**ARTICLE I. Name**

The name of this Corporation shall be:

**Digital Data Trust, Inc.**

**ARTICLE II. Principal Office**

The address of the principal office and the mailing address of the Corporation is 2100 Hestia Loop, Unit 546, Oviedo, FL 32765.

**ARTICLE III. Business and Activities**

This Corporation is formed for the purpose of, and authorized to engage in, research, training, and other activities concerning healthcare data security and utilization.

**ARTICLE IV. Initial Director and Election of Directors**

Section 1. The number of Directors of this Corporation shall be three (3).

Section 2. The number of Directors may be either increased or diminished from time to time as set forth in the Bylaws of this Corporation, but there shall always be at least three (3) and no more than thirteen (13) Directors.

Section 3. The Directors shall be elected by the prior Board of Directors.

Section 4. Any Director may be removed from office by two-thirds of the other Directors at any regular or special meeting of the Directors of this Corporation, for any cause deemed sufficient by such Directors or for no cause.

**ARTICLE V. Initial Officer**

The name of the initial executive director of this Corporation, to hold office until his successor is appointed by the Board of Directors and has qualified, is James F. Kragh.

**ARTICLE VI. Term of Existence**

The effective date upon which this Corporation shall come into existence shall be the date of filing of these Articles, and it shall exist perpetually thereafter unless dissolved according to law.
