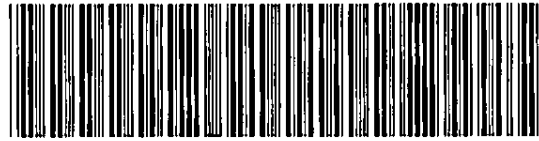

Article III Purpose: The purpose for which the corporation is organized is: St. Luke's P&P

· in existing perpetually, to impact the local and global communities with the Gospel of the Lord Jesus Christ (James 3:18) and the admissions of Heaven, exclusively for charitable, religious, educational, scientific, historical, and communal purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. With few exceptions, no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above and hereof. In making peace, no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to negatively influence legislation, and the church or corporation shall not participate in, or intervene in (including the publishing or distribution of statements) in any political campaign on behalf of, or in opposition to any candidate for public office. Notwithstanding any other provision of these measures, the church shall not carry on any other activities not permitted to be carried on (a) by a corporation exempted from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any federal future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding future federal tax code. Upon the dissolution (but forbid less needed) of the corporation, after paying all bills and liabilities, assets shall be distributed for one or more exempted purposes to another church chosen by the founders immediate family, and approved by a majority vote of the Board. The church exists to provide ministry divisions and to administer ordinations and endorsements for rightful ministerial causes.
