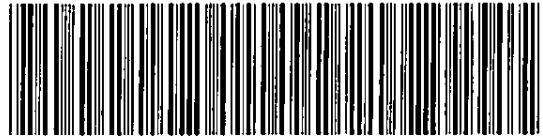

ARTICLE I NAME

The name of the corporation shall be: ABA Climate Coalition, Inc.

ARTICLE III PURPOSE

The purpose of the ABA Climate Coalition, Inc., a nonprofit public benefit corporation, is to increase climate action in the field of behavior analysis by promoting collaboration, awareness, education, research, and career paths in climate change to conserve and protect the natural environment. The ABA Climate Coalition, Inc. (the "Corporation") is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code to increase climate action in the field of applied behavior analysis (ABA) by promoting collaboration, awareness, education, research, and career paths in climate.

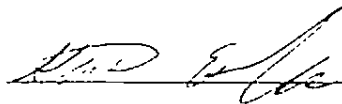
