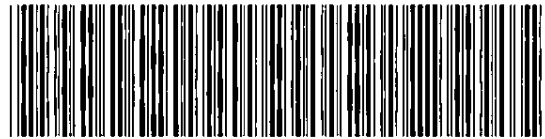

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned hereby makes, subscribes, acknowledges, and files with the Florida Department of State these articles of incorporation for the purpose of forming a corporation for profit in accordance with the laws of Florida.

ARTICLE I

Name

The name of this corporation shall be Jupiter Warriors Baseball Booster Club, Inc.

ARTICLE II

Principal's Place of Business

The principal place of business of the corporation shall be located at 500 Military Trail, Jupiter, FL 33458, with any other place of business as may be determined and fixed by the board of directors from time to time. The mailing address of the corporation's registered agent shall be 4870 County Line Rd Tequesta, Florida, 33469.

ARTICLE III

Purpose

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of the Jupiter Warriors Baseball Booster Club, Inc., is to support and enhance the baseball program at Jupiter Community High School through fundraising, volunteer efforts, and community engagement. As a non-profit organization, our mission is to provide financial and moral support to student-athletes, coaches, and the overall program, ensuring they have the necessary resources to succeed both on and off the field.

We are committed to:

- Raising funds for equipment, uniforms, travel, and facility improvements
- Promoting sportsmanship, teamwork, and community pride
- Encouraging parental and community involvement
- Supporting coaches and players through volunteer coordination and special events
- Enhancing the overall experience for all student-athletes in the baseball program

The Booster Club operates independently from school administration but works in partnership to ensure alignment with school policies and goals. All funds raised directly benefit the baseball program and help create a positive, competitive, and enriching environment for our athletes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes outlined in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation

exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION

As provided more specifically in the Bylaws, the officers are voted on annually at the designated annual meeting.

ARTICLE V INITIAL OFFICERS AND/OR DIRECTORS
