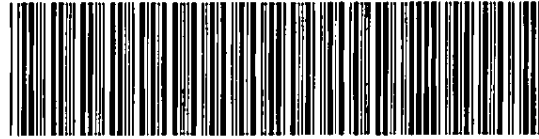



The undersigned subscriber to these Articles of Incorporation is a sole person competent to contract and hereby forms a Corporation not for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is:

US LIGHTING MANUFACTURERS ASSOCIATION, INC.

ARTICLE II

PURPOSE

This corporation is formed for the purpose of promoting the health and safety of consumers of products produced by companies involved in the manufacturing of all manner of lighting.

It is the specific intention of this corporation to act only for purposes allowed by Section 5.01(c) (3) of the Internal Revenue Code.

No monies generated by the activities of this corporation will be paid to Directors or Members of the corporation.

ARTICLE III

MANNER OF ELECTION

Directors to the Board shall be appointed by the Initial Board Directors. Thereafter, when any Director vacates a Board position, the remaining Director shall elect a replacement. The Board shall never have fewer than two (2) Directors but may be increased from time to time by a vote of a majority of the Directors then in office.
