

# SCHEDULE OF AMENDMENT TO ARTICLES OF INCORPORATION OF GOLF VIEW VILLAS IV CONDOMINIUM ASSOCIATION, INC.

- 1. Article III, Power, Section 3.2, paragraph (f), of the Articles of Incorporation shall be amended to read as follows:
  - f. To make and amend reasonable rules and regulations respecting the use of the property in the condominium, other than the restrictions contained in the Declaration of Condominium. ; provided, however, that all such regulations and their amendments shall be approved by not less than seventy-five percent of the votes of the entire membership of the Association before such shall become effective.
