Pursuant to the provisions of Florida Statutes Section 617.1006, this Florida Non-Profit Corporation adopts the following amendments to its Articles of Incorporation:

## ARTICLE I

## CORPORATION NAME

The corporation name is amended and shall be henceforth called CENTRAL CONGREGATION OF JEHOVAH'S WITNESSES, TITUSVILLE, FLORIDA, INC.

## ARTICLE II

#### PRINCIPAL OFFICE

The principal office, street address, and mailing address of the Corporation is now 770 Dixie Avenue, Titusville, Brevard County, Florida, 32796.

## ARTICLE III

## CORPORATION PURPOSE

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be earried on, (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States tax code), or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States tax code).

## ARTICLE IX

## DISSOLUTION OF CORPORATION

Upon the winding up and the dissolution of the Corporation, after paying, or adequately providing for the debts, obligations, liabilities, and expenses of the

Corporation, the remaining assets shall be distributed to the Watchtower Bible and Tract Society of New York, Inc. No assets shall be deemed to be received by Watchtower Bible and Tract Society of New York, Inc. until such acceptance is evidenced in writing. If Watchtower Bible and Tract Society of New York, Inc. is not then in existence and exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States tax code), then said assets shall be distributed to any organization designated by the ecclesiastical Governing Body of Jehovah's Witnesses that is organized and operated for religious purposes and is a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States tax code).
