The FEI Number on the enclosed form is incorrect. The correct number is 65-0049973.

The confusion arises out of the following facts. On April 27, 1988 Wildfield Properties of Florida, Inc. whose principal was Donald T. Huggins, Jr. filed a Master Declaration of Covenants, Conditions, Reservations and Restrictions of Sandpainte Subdivision covering certain property in Indian River County. The property described was on an acreage description. This Declaration recited that the Developer had formed a non-profit corporation namely Sandpainte Property Owners Association, Inc. which was filed on April 29, 1988. It was not until June 6, 1988 that the plat of Sandpainte Subdivision was filed (Plat Book 12 Page 67 Public Records of Indian River County) which plat included that portion of the acreage description extending from State Road A1A east to the Atlantic Ocean. Not quite two years later the Developer filed a plat of Sandpainte West Subdivision (Plat Book 13 Page 31) filed April 16, 1990. This subdivision covered the portion of the acreage description that extended from A1A west to the Indian River. Both subdivisions namely "Sandpainte" and "Sandpainte West" were covered by the Master Declaration and subsequent Amendments and property owners in both subdivisions were members of the Sandpainte Property Owners Association, Inc. which had duly

In the latter part of 1990 and early 1991, the developer
Hidfield Properties of Florida, Inc. had financial
difficulties and abandoned both subdivisions. A few of
the property owners in Sandpoint Subdivision instead of
calling a meeting of Sandpoint Property Owners Association,
Inc. and taking control of the subdivision formed
what they called "Sandpoint East Homeowners Committee"
which while it had no legal standing since there is no
Sandpoint East Subdivision, proceeded to open a bank
account, collect assessments etc. In opening the account
they used the FEI number of Sandpoint Property Owners
Association, Inc. In May of 1991, the Internal Revenue
Service noticed that Sandpoint East Homeowners Committee
was using the corporate FEI assigned a new number
to the so called Committee, a copy of this notice is attached
hereto. Since then the various persons taking control of
Sandpoint Property Owners Association, Inc. have along
with various accountants preparing tax returns confused the
issue by using the number assigned to the Committee
instead of the proper number of Sandpoint Property
Owners Association, Inc. which always has been
