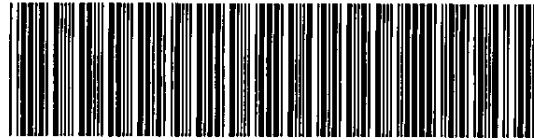



ARTICLES OF MERGER
OF WAGG MEMORIAL UNITED METHODIST CHURCH, INC.
INTO UNITED METHODIST CHURCH OF THE PALM BEACHES, INC.

The following articles of merger were executed by WAGG MEMORIAL UNITED METHODIST CHURCH, INC. ("WAGG MEMORIAL") and UNITED METHODIST CHURCH OF THE PALM BEACHES, INC., ("UNITED METHODIST"), both Florida corporations not for profit, to record and establish their merger, as follows:

1. Adoption of Plan of Merger by Each Corporation. The Board of Trustees of WAGG MEMORIAL submitted the plan of merger hereinafter described, after notice to its members as required by its bylaws and the Discipline of the United Methodist Church. The membership voted to approve the merger on October 7, 2006. UNITED METHODIST, after notice to its members as required by its bylaws and the Discipline of the United Methodist Church, voted to approve the merger on October 18, 2006.

2. Plan of Merger. The plan of merger approved by the membership of both corporations, provides that, effective January 1, 2007, WAGG MEMORIAL will be merged into UNITED METHODIST so that the surviving corporation will be UNITED METHODIST CHURCH OF THE PALM BEACHES, INC. All assets and liabilities of WAGG MEMORIAL will become assets and liabilities of UNITED METHODIST CHURCH OF THE PALM BEACHES, INC. The obligations and benefits of all executory contracts of WAGG MEMORIAL will become obligations and benefits of UNITED METHODIST CHURCH OF THE PALM BEACHES, INC.

3. Effective Date. The merger is effective January 1, 2007.

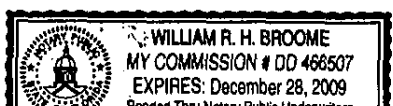
