# RESTATED ARTICLES OF INCORPORATION

To further common purposes the undersigned persons agree to organize under these articles of incorporation.

### ARTICLE 1. NAME

The name of this organization shall be SUNDANCE HOMEOWNER ASSOCIATION, INC.

### ARTICLE 2. PRINCIPAL OFFICE

The principal office of the association shall be at 6315 Santa Fe Drive, Zephyrhills, Florida, 33540.

### ARTICLE 3. PURPOSES

The purposes for which this association is formed are:

- A. To own, operate, and maintain a club exclusively for the pleasure, entertainment, recreation and protection of homeowners at SUNDANCE MOBILE HOME PARK, Zephyrhills, Florida.
- B. To do anything necessary and proper for the accomplishment of any purposes set forth in the statement of purposes adopted by the founders of this association.
- C. The association is organized and operated exclusively for the above stated purposes, and for other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any member.

#### ARTICLE 4. POWERS

In furtherance of the objectives described above, but not in limitation thereof, the association shall have the power, insofar as such power is conferred, or is not limited, by law, to make and perform contracts for any lawful purpose, to engage in various funding and fund-raising activities, and to acquire, own, hold, operate, and maintain such property as is necessary to effectuate its purposes.

In addition, the association shall have the power to negotiate for, acquire and operate the mobile home park on behalf of Homeowners Association and if so purchased, the Homeowners Association shall have the power to convert the mobile home park, once acquired, to a condominium, a cooperative form of ownership, or other type of ownership.

Upon acquisition of the property by the association, the association shall be the entity that creates a condominium or offers condominium parcels for sale or lease in the ordinary course of business, or, if the homeowners choose a different form of ownership, the entity that owns the record interest in the property and that is responsible for the operation for the property.

#### ARTICLE 5. MEMBERSHIP

- A. The association shall have only one class of members. Membership shall be limited to homeowners.
- B. The rights and privileges of members, their liability for dues and assessments, and the termination and transfer of membership shall be as stated in the bylaws.

# ARTICLE 6. VOTING

At a special meeting on December 6, 1993, an amendment was made to ARTICLE SIX (6) voting to read. There will be one vote per dues paying member of the Homeowners Association. The details and total ballots is filed with the meeting minutes in the Secretary's Cabinet.

### ARTICLE 7. GOVERNING BODY

The powers of the association shall be exercised and its property controlled by the Board of Directors, comprised of nine (9) members. The qualifications, the time and manner of electing, the terms and duties of office, and the manner of filing vacancies shall be set forth in the bylaws.

# ARTICLE 8. OFFICERS AND COMMITTEES

Elective officers: The officers of this association shall be president, vice president, secretary, and treasurer. The qualifications of, the time and manner of electing, the duties of, the terms of office, and the manner of removing, officers shall be set forth in the bylaws.

### ARTICLE 9. AMENDMENTS OF ARTICLES

The articles my be amended or repealed, in whole or in part, only by a majority vote of the registered voters of this association. Such vote shall take place only at a duly organized annual or special meeting called for that purpose.

THE CHANGES IN THE ARTICLES OF INCORPORATION WERE APPROVED BY 87% OF THE MEMBERS THAT VOTED. A VOTE OF AT LEAST 2/3s OF THE MEMBERS WAS THE REQUIREMENT FOR PASSAGE.

### ARTICLE 10. BYLAWS

Bylaws will be hereafter adopted. Such bylaws may be amended or repealed, in whole or in part, in the manner provided therein, and the amendments to the bylaws shall be binding on all members, including those who may have voted against them.

# ARTICLE 11. DISSOLUTION

This association shall be dissolved and its affairs wound up by a majority vote of the association's membership.

In the event of dissolution, property of the association shall be distributed in any manner lawfully entitled by law and approved by majority vote of the association's membership.

# ARTICLE 12. REGISTERED AGENT

This corporation has named JOHN HOLDEN, located at 6315 Santa Fe Drive, Zephyrhills, Florida 33540, as its agent to accept service of process within this state.

AGENT UPON WHOM PROCESS MAY BE SERVED.

IN PERSUANCE OF CHAPTER 48.091, FLORIDA STATUES, THE FOLLOWING IS SUBMITTED, IN COMPLIANCE WITH THE SAID ACT:

FIRST—THAT SUNDANCE HOMEOWNERS ASSOCIATION, INC. DESIRING TO ORGANIZE UNDER THE LAWS OF THE STATE OF FLORIDA WITH ITS PRINCIPAL OFFICE, AS INDICATED IN THE ARTICLES OF INCORPORATION AT CITY OF ZEPHYRHILLS, COUNTY OF PASCO, STATE OF FLORIDA, HAS NAMED JOHN HOLDEN, 6315 SANTA FE DRIVE, ZEPHYRHILLS, FLORIDA 33540, COUNTY OF PASCO, STATE OF FLORIDA, AS ITS AGENT TO ACCEPT SERVICE OF PROCESS WITHIN THIS STATE.
