# AMENDMENT TO THE ARTICLES OF INCORPORATION OF PALOMAR AT BOCA POINTE HOMEOWNERS' ASSOCIATION, INC.

## ARTICLE VIII

### **AMENDMENTS**

Amendments to these Articles of Incorporation shall require the affirmative vote of a majority of the Board of Directors and the affirmative vote of two-thirds of the Members of not less than a majority of the eligible voting interests of the Association; provided, however, that (a) no amendment shall make any change in the qualifications for membership nor the voting rights of the Members without written approval or affirmative vote of all Members of the Association, (b) that these Articles shall not be amended in any manner without the prior written consent of the Developer to such amendment for so long as the Developer is the Owner of any Lot, and (c) that these Articles shall not be amended in any manner which conflicts with the terms, covenants and provisions contained in the Declaration.
