THE MEETING WAS CALLED TO ORDER AT 7:05P.M.. LINDA SAID THE PRAYER AND LED THE SALUTE TO THE FLAG. ROLL CALL-FOUR OFFICERS WERE EXCUSED THE ELECTION COMMITTEE WAS FORMED: HERB SPIEGLE, HELEN La CERT, AND MILLIE CARTER. THE ELECTION WAS HELD AND WHILE THE VOTES WERE BEING COUNTED, LINDA READ THE MINUTES OF THE APRIL 01 BOARD OF DIRECTORS AND MEMBERSHIP MEETING. THE MINUTES WERE ACCEPTED AS READ. AFTER VERIFIEG THE COUNT THE BALLOTS AND THE RESULTS WERE GIVEN TO THE SECRETARY WHO ANNOUNCED TONY ANGELINI THE WINNER FOR THE VICE-PRESIDERTS OFFICE. BALLOTS WILL GO ON FILE FOR ONE YEAR IN ACCORDANCE WITH OUR BY-LAWS WE HAVE 144 PAID UP MEMBERS AT PRESENT.
