In the event that Chancey Road Christian Church (Independent), Inc. located at 34921 Chancey Road Zephyrhills, Florida, shall ever be permanently disbanded, all assets remaining after all liabilities have been settled shall be distributed to an approved Christian Church/New Testament Church in the Restoration Movement. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
