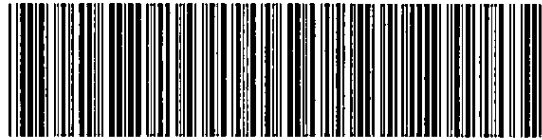

Amending Article II: adding an adequate purpose clause as instructed under IRS Section 501(c)(3): The addition is as below:

This organization is organized exclusively for charitable, religious, and educational, benevolent, and social activities for the training, and promotion of the Christian Faith. Such purpose includes but is not limited to reaching out in faith, to feed and cloth the poor and needy, under section 501(c)(3) of the Internal Revenue Code, OR any corresponding section of any future federal tax code.

Amending Article V: Per IRS IRC Section #74828(b)(2), to clarify dissolution of this organization: Article V will now read:

This corporation is to exist perpetually. However upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or for such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
