CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HOMEOWNERS' ASSOCIATION OF VILLA DEL MAR, INC.

NOTICE IS HEREBY GIVEN that the Articles of Incorporation of HOMEOWNERS' ASSOCIATION OF VILLA DEL MAR, INC., a Florida corporation not for profit, as originally filed on July 15, 1988 with the Secretary of State of the State of Florida, are hereby amended by the members of the Association, pursuant to the procedures described in said Articles of Incorporation for amendment thereof, at the Annual Meeting of the members on April 21, 2008, as set forth herein:
