The name of the corporation is Tampa Bay Area Broadcasters Association, Inc.

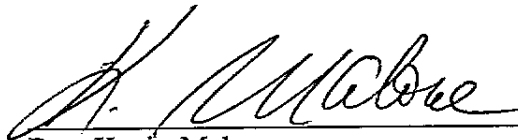
ARTICLE II
